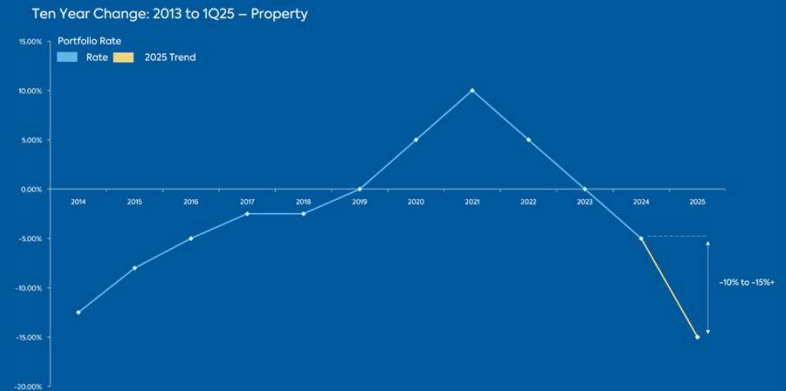


DATA AND ANALYTICS
