The 11th Annual Saskatchewan Suppliers Energy Forum (SSEF) will be on Wednesday, October 8, 2025 at Delta Hotel in downtown Regina, SK. This event is co-hosted by SIMSA and the Saskatchewan Ministry of Trade & Export Development.

At this one-day event, there will be a small vendor tradeshow, presentations by energy company procurement persons, and networking sessions. Confirmed presenters include CAPP, Cenovus, FCL, Saturn Oil + Gas Inc., Strathcona Resources Ltd., Prairie Lithium, and SaskPower.

This year's event is on track to be at least 25% larger than last year's and will be one of the largest ever.

Planning for the BHP Roundtable on November 6 is well underway. As part of this event, **BHP** has asked for pre-submitted questions from the SIMSA membership by October 6. Nuclear Update - October

During the month of September, we were focused on delivering our SIMSA cohort program "Supplying the Nuclear Industry", member tours in support of understanding the capabilities and capacity that can be utilized in the nuclear industry, supporting the execution of the NRCan project "Enabling SMRs" and attendance at the OCNI nuclear supply chain meetings in Toronto.

Nuclear related activities – Month of September:

- 1) NRCan Funded Enabling SMRs Project Project is focused on developing the nuclear supply chain in Saskatchewan in 4 key areas:
 - a. Fabrication and Manufacturing
 - b. Fuel Cycle
 - c. Deployment and Construction
 - d. Operations and Maintenance

- 2) Delivery started on the 12-week cohort-based program focused on introducing SIMSA members on how to supply items and services to the Nuclear Industry. Modules 1, "Overview", Module 2 "Regulatory Standards and Frameworks", and Model 3 "Fundamentals of Nuclear Quality" were delivered in 3 successive weeks.
- 3) Participated in the planning meetings for the SaskPoly & SIMSA Workshop on Nuclear Supply Chain and Workforce Development scheduled post CNA West in Saskatoon on October 23
- 4) Attended OCNI nuclear supply chain event in Toronto "Industry Day" September 10 and 11

SIMSA Advances Pan-Canadian Innovation MOU and Leads Critical Nuclear Supply Chain Study

SIMSA is pleased to share two major developments that we believe will create member value.

1) Partnership in Mission Decarbonization with MISA, Corem & National Collaborators

SIMSA has joined as a strategic collaborator in **Mission Decarbonization**, an initiative led by Québec's MISA Group and Corem, to accelerate decarbonization in Canada's mining sector. **Groupe MISA**

Through this collaboration, SIMSA (and its members) becomes part of a pan-Canadian network alongside Foresight Canada, InnoTech Alberta, Saskatchewan Research Council (SRC), and ReThink Mining. These organizations will pool regional strengths in innovation, clean technologies, and sustainable development to support the mining industry's transition to lower-carbon operations across Canada.

The alliance will focus on:

- Reducing carbon footprints of mining operations through new technologies and practices
- Strengthening regional innovation ecosystems
- Promoting knowledge sharing and joint project development across provinces
- Positioning Canada and Saskatchewan as a leader in responsible, low-carbon mining globally

SIMSA's involvement helps ensure that Saskatchewan's suppliers, technologies, and industrial capacity are plugged into national clean-mining and decarbonization efforts.

2) SIMSA to Lead Major SMR Supply Chain Study in Saskatchewan

In parallel, SIMSA has been awarded a significant contract by Natural Resources Canada to lead a province-level study aiming to strengthen Saskatchewan's Small Modular Reactor (SMR) supply chain.

Project Overview & Objectives

- Total funding for the project is \$4,015,636, composed of contributions from NRCan, Cameco, and in-kind support from project partners. Pipeline Online+2Simsa+2
- SIMSA will partner with technical lead March Consulting Associates Inc., the Saskatchewan First Nations Natural Resource Centre of Excellence (as Indigenous lead), and Westinghouse Electric Canada providing nuclear domain expertise.
- The study will examine key dimensions of SMR supply chain development: manufacturing, nuclear fuel cycle, deployment & construction, operations & maintenance.

- It will assess Saskatchewan's current supplier capabilities, identify gaps, and propose strategies to increase local and Indigenous supplier participation in nuclear.
- The project includes three detailed case studies to deliver actionable insights for local suppliers and investment decisions.

Strategic Significance

This initiative represents an important stepping stone in positioning Saskatchewan as a competitive hub in Canada's emerging SMR industry. The findings are expected to guide both private and public sector stakeholders in understanding where capacity exists, where development is needed, and how to coordinate for maximum economic impact.

Furthermore, the emphasis on Indigenous participation aims to embed economic reconciliation into the expanding nuclear ecosystem.

What This Means for SIMSA Members

- Access to new networks & innovation platforms: Through Mission Decarbonization, SIMSA members may gain exposure to cross-province clean technology initiatives and partnerships.
- **Opportunities in nuclear supply chain:** The SMR study may uncover new supplier roles, gaps to fill, and pathways for qualification in future projects.
- **Strategic insights & capacity building:** The delivered study and collaborations will provide actionable guidance for investment and capability development.

We look forward to keeping you informed on milestones, collaboration calls, and opportunities that emerge from both of these initiatives.
